This year, we launched <u>RealizeU</u>, a multidisciplinary education program for emerging and established leaders, designed and instructed by the experts at Realize Strategies.

We equip leaders with practical tools and strategies, applied industry insights, and flexible leadership skills to handle current and future workplace challenges with resilience and empathy.

Our longstanding Community Innovation Cash Pool Program (CICPP) focusses on amplifying the strengths and impact of our members. Operated in partnership with Vancity Credit Union, our CICPP offers non-profit and co-operative members premium interest rates on their deposits. By pooling member accounts into one large depositor, we are able to offer our Pool members an exclusive premium interest rate of Prime – 1.85%. Over the last fiscal year, our Community Innovation Cash Pool Program generated over \$3.26 million in interest payments for our members to be reinvested in the communities they serve!
